This amendment forms part of Military Specification MIL-P-514D, dated 15 September 1966, and is mandatory for use by all Departments and Agencies of the Department of Defense.

- 1.2 Type I, Style 2. Delete in its entirety.

PAGE 2

- 2.1 Federal. Delete the following:

"PPP-B-576 - Box, Wood, Cleated, Veneer, Paper, Overlaid.
PPP-B-591 - Boxes, Fiberboard, Wood-Cleated."

Military. Add the following:

"MIL-B-46506 - Box Ammunition, Packing, Wood, Wirebound."

- 2.1 STANDARDS, Military. Delete:

"(see Supplement 1 for list of Associated MS Standards)" and substitute:

FSC 9905

3.2, line 9. Add to the last sentence, "(see 6.5)".

3.3.2.1, lines 5 and 6. Delete "shall be 24-point type.....not more than 14 points", and substitute, "shall be not less than 24-point type, and all other letters shall be not less than 6 points, unless otherwise specified (see 6.2)."

3.5 Delete the second sentence in its entirety.

PAGE 10

Table II, following 103: Delete the sentence in its entirety and substitute. "Plate not formed with opposite sides parallel within 1/32 inch or adjacent sides at $90 \pm 1/2$ degree angle."

PAGE 11

Table II, following 107, second line: Delete period and add, "within tolerances specified on applicable standard or drawing".

PAGE 14

5.2.1 Delete and substitute:

"5.2.1 Level A. Plates shall be packed in wire bound boxes, nailed wood and cleated-plywood boxes conforming to PPP-B-585 (class 2), PPP-B-621 (class 2), PPP-B-601 (overseas type) and MIL-B-46506. Flat steel strap-ping shall be type I, class B."

6.1.2 Delete in its entirety.

6.1.3, line 4. Delete "MS 63200".

PAGE 17

"6.5 Fasteners. When fasteners used for attaching the plate to the equipment are electrochemically incompatible with the base equipment and the plate, consideration should be given to the protection of the fasteners with a minimum 0.0005-inch cadmium plate in accordance with QQ-P-416, type II."
