This amendment forms a part of MIL-P-63462(AR), dated 10 September 1979, and is approved for use by all Departments and Agencies of the Department of Defense.

3.1.2: Delete section 3.1.2 in its entirety and substitute the following:

"3.1.2 Plasticizer, substituted phenyl ether – with bis (p-1, 1'3, 3' tetramethyl butyl phenyl) ether as the principal constituent. Dow P-1099 plasticizer is the only Government-approved commercial form of this material currently authorized for use.

(2) Absorption Coefficient	0.23 Max.
(3) Viscosity at 25°C: m ² /s (Centistokes)	4 – 8 X 10 ⁻³ (4000 – 8000)
* (4) % volatiles (148.5°C and 4mm Hg pressure for one hour using a 10 g sample in a 30 ml standard Griffin beaker), maximum	9
(5) Acid Number, maximum	0.5
(6) Specific Gravity, 25/4 degrees C	0.92 – 0.95"
