

MILITARY SPECIFICATION

PLASTIC MATERIAL, LAMINATED, THERMOSETTING, ELECTRICAL INSULATION:

SHEETS, GLASS CLOTH, SILICONE RESIN

This amendment forms a part of Military Specification MIL-P-997D, dated 23 November 1966, and is mandatory for use by all Departments and Agencies of the Department of Defense.

Page 4

4.1: Delete and substitute:

"4.1 Responsibility for inspection. - Unless otherwise specified in the contract or purchase order, the supplier is responsible for the performance of all inspection requirements as specified herein. Except as otherwise specified in the contract or order, the supplier may use his own or any other facilities suitable for the performance of the inspection requirements specified herein, unless disapproved by the Government. The Government reserves the right to perform any of the inspections set forth in the specification where such inspections are deemed necessary to assure supplies and services conform to prescribed requirements."

Table IV, columns 6, 7, and 8, flexural strength tested flatwise at 23°C., opposite "cut lengthwise" and "cut crosswise": Delete and substitute:

"24,000	23,000	18,000
21,000	20,000	15,000"

Table IV, column 7, dissipation factor at 1 megacycle: Delete "0.018" and substitute "0.022".

Table V, columns 7 through 12, flexural strength tested flatwise at 23°C., opposite "cut lengthwise" and "cut crosswise": Delete and substitute:

"24,000	23,000	20,000	19,000	18,000	16,000
21,000	20,000	17,000	15,000	15,000	13,000"
