MILITARY SPECIFICATION

RIFLES, U. S., CALIBER .30, M1 AND M1C

This amendment forms a part of Military Specification MIL-R-3285, 8 September 1960, and has been approved by the Department of the Army, the Navy, and the Air Force

Page 1, section 1: Delete and substitute:

"1. SCOPE

"1.1 This specification covers caliber .30, semiautomatic rifles. The rifles shall be furnished in the following models, as specified (see 6.2):

Rifle, U. S., Caliber .30, M1.

Rifle, U. S., Caliber .30, M1C."

Page 1, section 2: Delete and substitute:
