"3.4.6 Anchor stake and driving head. Anchor stakes shall be as shown on drawing 13225E9188 and the driving head shall be as shown on drawing 13225E9189."

"3.4.10 Hoist. The hoist shall be a Beebe Model LH300A or equal."

* 5.2.3, line 2, delete "MIL-STD-1188" and substitute "ASTM D 3951".
