3.1 Delete entire paragraph and add the following:

Reclaimed Materials. Recycled and recovered raw material should be used to the maximum extent possible in lieu of virgin raw materials as long as these materials do not jeopardize the intended use and fully comply with all contract requirements. Materials used shall be free from defects which would affect the performance or maintainability of individual components of the overall assembly.

3.1.2 line 5 delete "Standard MS33586" and replace with "MIL-STD-889

3.3.2.2 Maximum weight for 6 gallon unit.
Delete "10 pounds" and substitute "15 pounds."

Figures 1, 2 and 3. Add under tolerances:
