MILITARY SPECIFICATION

TRANSOLVERS, GENERAL SPECIFICATION FOR

This amendment forms a part of Military Specification MIL-T-83727, dated 24 September 1969, and is mandatory for use by all Departments and Agencies of the Department of Defense.

Page 1

1.2.1, delete third item "T, Function, 1.2.1.3" from type designation. Add new item between "S, Primary element" and "Y, Primary winding" as follows: "47, Impedance of input winding, 1.2.1.9."

1.2.1.1, delete and substitute:

"1.2.1.1 Voltage. For 115-volt units, this space shall be left blank. All other units shall be designated with the primary voltage specified in the applicable specification sheet."

1.2.1.3: Delete.

Page 2

Add following paragraph after 1.2.1.3:

"1.2.1.9 Impedance of input (primary element) winding. The impedance of the primary element shall be the nominal input impedance in multiples of 10 ohms. If the impedance is not exactly a whole number of tens, the next higher ten shall be used as illustrated below:

3.3, delete in its entirety and substitute:

"3.3 First article. When required by the procuring activity, transolvers shall conform to the requirements specified herein and shall have met the first article inspection specified in 4.5 prior to regular production on a contract or order (see 6.6)."

6.4.1, add the following sentence at the end of the second sentence: "When two shaft extensions exist, the one opposite the lead or terminal end shall be applicable for this definition."
