3.3.3, Delete: "Cloth, duck, nylon. The nylon cloth used for the radio pocket back shall conform to type III, class 1 of MIL-C-7219. The color shall be Olive Green 106." and substitute: "Cloth, ballistic, nylon, light-weight, water-repellent treated. The cloth used for lining the radio pocket and radio pocket back shall conform to class 2, of MIL-C-44043."

"3.3.12.2 Slides. The slide shall be black, 3/4 inch wide, brass and conform to ITW Waterbury, part #00171-22. A quantity of two is required per vest."
