2.2 Under "AMERICAN SOCIETY FOR TESTING AND MATERIALS" add the following title:

ASTM D3159 - Modified ETFE-Fluoropolymer Molding and Extrusion

Add the following new paragraph after 3.3.2.3:

3.3.2.4 Extruded ethylene-tetrafluoroethylene. When extruded ethylene-tetrafluoroethylene is specified in the specification sheet, the material shall be type I or type II of ASTM D3159.

PAGE 5

3.5.3.1 Add the following at the end of the last sentence of the paragraph:

"except that the minimum distance between splices, similarly determined, for wires with polytetrafluoroethylene as an insulation component shall be 500 feet in any drum, reel or spool. This exception shall not apply to copolymers.
