"2.2 Other publications. The following document(s) form a part of this specification to the extent specified herein. The issues of the documents which are indicated as DoD adopted shall be the issue listed in the current DoDISS and the supplement thereto, if applicable."

"6.2 Ordering data.

6.2.1 <u>Acquisition requirements</u>. Acquisition documents should specify the following:

(a) Title, number, and date of this specification.

(b) Material designation (see 1.3).

(c) Width of cloth required (see 3.2.4.4).

(d) Selection of applicable levels of packaging and packing (see 5.1 and 5.2).

(e). When weather-resistant grade fiberboard shipping containers and panels are required for level B packing (see 5.2.2.1).

(f) When palletization is required (see 5.4).


