z. Page 21, figure 4, change "Federal Stock Number" to "National Stock Number." Delete "NATO" and dividing line that follows. Change "FIIN" to "NIIN."

aa. Page 22, top right corner. Change "FSN" to "NSN." Change "1560-738-2462BF" to "1560-00-738-2462BF." Lower right corner, change dates to 72130, 72135, and 72140. Lower right corner, change "8145NDO2176CBF" to "00-738-2462."

ab. Page 23, lower right corner. Change dates to 72140, 72142, 72145, and 72150. Change "8145NDO21760BF" to "00-738-2462."

ac. Page 25, lower right corner. Change "5841-633-7596" to "00-633-7596."

ad. Page 26, paragraph 40.3. Add to end of sentence: "In no instance shall be drawing size impair the clarity or legibility of the TPO."

ae. Page 27, paragraph 40.4, line 1, change "Federal Item Identification Number" to "National Item Identification Number."

af. Page 27, paragraph 40.5, add to end of first sentence: "by the lowest skilled packer."

ag. Page 27, paragraph 40.5.1(h), insert at beginning of sentence: "Markings as specified by MIL-STD-129 as well as special marking"

However, the basic preservation method shall be retained, and unit package dimensions shall not be increased. There shall be no increased cost to the Government and equal or better protection shall be given the item. Prior approval of the procuring activity is not required under these conditions.						
		(d) Enter "E" to indicate that options can be exercised as to the submethod and/or some of the packaging materials to be used but not all of them. In such cases, the options that may be exercised must be indicated in supplemental data. However, the basic preservation method shall be retained and unit package dimensions shall not be increased. There shall be no increased cost to the Government and equal or better protection shall be given the item. Prior approval of the procuring activity is not required under these conditions.						
		(e) Optional procedures codes F, S, or R - These codes provide for special options as they apply to use of polyurethane foam-in-place for other than TPO items and will supplement the coded data. The codes relate to MIL-P-26514 and are

4.1.5 Supplemental Data

4.1.5.1 Air Force. These supplemental data are pertinent to the packaging process and are required in addition to that shown in the preservation and packaging data area. Supplemental data shall be recorded in concise narrative form as described below. Narrative shall show only explanatory or instructional type information which directly supplements the elements of the packaging requirements code in the preservation and packaging data area. A TPO will be developed when supplemental data does not include sufficient detail to reproduce the complete package without additional information. TPOs which includes narrative and Fast Pack TPOs, shall be developed for all items with expendability/recoverability/reparability codes (ERRC) "C," "T," or "S" that are subject to shipment as an individual item between field activities and a depot or contractor repair facility.

4.1.5.1.1 A maximum of seven lines of supplemental data is permitted for any one item. If necessary supplemental data would exceed seven lines, a TPO shall be prepared in accordance with instructions in Appendix I.

4.1.5.2 Navy. When the preservation and packaging data area does not contain all necessary requirements, a TPO shall be prepared in accordance with instructions in Appendix J.
