1. SCOPE

1.1 Purpose. This Military Standard establishes the color coding to be used by textile manufacturers for the purpose of identifying their respective products, when so specified by the detail specification for the material or by the procuring activity.

1.2 Color samples. Samples of the colors to be used may be obtained from the Commander, San Antonio Air Materiel Area, Attention SANE, Kelly Air Force Base, Texas, 78241.
