1. SCOPE

1.1 Scope. This standard specifies a color code to provide a means for the positive identification of the manufacturers of certain types of nylon webbing. This code is intended to apply only to nylon webbing.

2. DETAILED REQUIREMENTS

2.1 Color assignment. The identification colors which have been assigned to specific manufacturers are as follows:

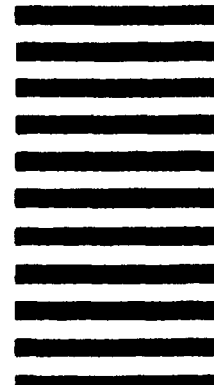
