MILITARY STANDARD
DESIGN CRITERIA FOR
AMMUNITION UNIT LOADS

TO ALL HOLDERS OF MIL-STD-1660:

1. Make pen and ink changes or add new paragraphs to the following pages.

Cover page:

Delete "Beneficial comments" statement.

Page ii:

a. Change "Department of Navy, Naval Sea Systems Command" to "Department of Defense."

b. Delete paragraph 1 and substitute:
"1. This Military Standard is approved for use by all Departments and Agencies of the Department of Defense."

c. Delete paragraph 3 and substitute:
"3. Beneficial comments (recommendations, additions, deletions) and any pertinent data which may be of use in improving this document should be addressed to: Commanding Officer, Naval Ordnance Station, Standardization Division, Code 6111, Indian Head, MD 20640, by using the self-addressed Standardization Document Improvement Proposal (DD Form 1426) appearing at the end of this document or by letter."

Page 3.

a. Add to top of page 3:
"STANDARDIZATION AGREEMENT

STANAG 2828

Military Pallets, Packages and Containers.

(Applications for copies should be addressed to: Superintendent of Documents, US Government Printing Office, Washington, DC 20402. Note: Issue-controlled, release to other than DOD Agencies must be approved by the Department of the Army Headquarters, Darcom (Drcird))."

b. Change "Bureau of Explosives" address to:

Page 3:

a. Add to TABLE I in the box for Military Airlift after "(half size)", asterisk (*).

b. Add the following explanation for asterisk in box opposite "Military Airlift": " * Logair pallet (HCU-10/C) is not compatible with the C-130, C-141 and C-5 aircraft."

Page 13:

a. Add new paragraph 5.5.

"5.5 Testing. Tests in MIL-STD-1660 fulfill the test requirements of STANAG 2828 and, therefore, may be used in lieu of STANAG 2828."

Page 14:

Replace existing "FIGURE 1" with new "FIGURE 1" attached.

2. RETAIN THIS NOTICE AND INSERT BEFORE TABLE OF CONTENTS.

3. Holders of MIL-STD-1660 will verify that the page changes indicated herein have been entered. This notice will be retained as a check sheet. This issuance is a separate publication. Each notice is to be retained by stocking points until the Military Standard is completely revised or cancelled.


