

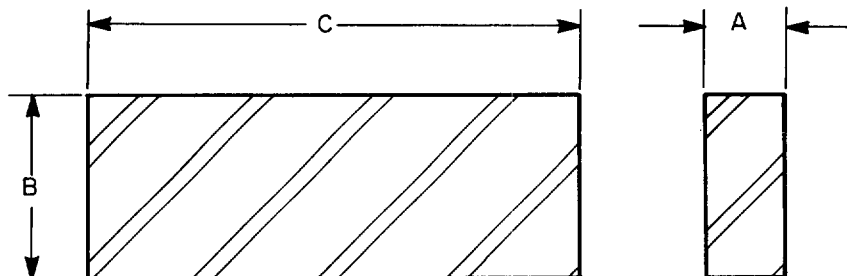

1. MATERIAL. STEEL, CORROSION RESISTANT, TYPE 321 (UNS S32100) AS SPECIFIED IN PROCUREMENT DOCUMENT.
2. FORMING PROCESS. HOT FINISHED - CODE "H"
3. ADDITIONAL REQUIREMENTS.

DESCALED OVERALL - CODE "ds"  
 PICKLED OVERALL - CODE "po"  
 SANDBLASTED OVERALL - CODE "sb"

4. PART NUMBER. THE PART NUMBER CONSISTS OF THE BASIC MS NUMBER, PLUS A FORMING PROCESS CODE, PLUS A DASH NUMBER FROM TABLE I.

BASIC MS NUMBER

5. MARKING. IRON AND STEEL PRODUCTS SHALL BE MARKED IN ACCORDANCE WITH FED-STD-183 WITH THE EXCEPTION THAT A PART NUMBER FROM THIS MILITARY STANDARD SHALL BE INCLUDED AS PART OF THE IDENTIFICATION MARKING.
