

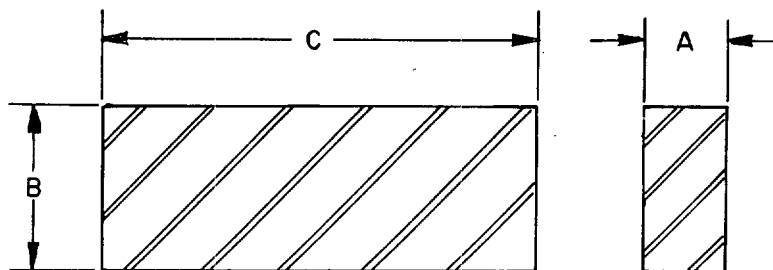

2. FORMING PROCESS. COLD ROLLED
3. ADDITIONAL REQUIREMENTS.

POLISHED OVERALL - CODE "p"
BRIGHT OVERALL - CODE "bo"

4. PART NUMBER. THE PART NUMBER CONSISTS OF THE BASIC MS NUMBER, PLUS A DASH NUMBER FROM TABLE I.
