



MS Part No. MS18253-1 - Suitable for all applications  
MS Part No. MS18253-2 - For long jackscrews and hood only (thru hole alternate construction)

NOTES

- Dimensions are in inches.
- Unless otherwise specified, tolerance is  $\pm .015$  (.38 mm).
- Metric equivalents (to the nearest .01 mm) are given for general information only and are based upon 1 inch = 25.4 mm.
- Tolerance between any two adjacent contact centers shall be  $\pm .004$  (.10 mm). Tolerance between any two contact centers, other than adjacent contacts, shall be  $\pm .006$  (.15 mm).
- Contact identification may be located on either side of the contact hole but shall appear on the front and rear of each insert.
- For design feature purposes, this standard takes precedence over procurement documents referenced herein.
- Referenced documents shall be of the issue in effect on date of invitation for bid.
