

1. Dimensions are in inches.
2. Unless otherwise specified, tolerance is $\pm .015$ (381 μ m).
3. Metric equivalents (to the nearest 0.1 mm) are given for general information only and are based upon 1 inch = 25.4 mm.
4. Tolerance between any two adjacent contact centers shall be $\pm .004$ (101 μ m). Tolerance between any two contact centers, other than adjacent contacts, shall be $\pm .006$ (152 μ m).
5. Contact identification may be located on either side of the contact hole but shall appear on the front and rear of each insert.
6. For design feature purposes, this standard takes precedence over procurement documents referenced herein.
7. Referenced documents shall be of the issue in effect on date of invitation for bid.
