

NOTES

- Dimensions are in inches.
- Unless otherwise specified, tolerance is ± 0.15 (.38 mm).
- Metric equivalents (to the nearest .01 mm) are given for general information only and are based upon 1 inch = 25.4 mm.
- Tolerance between any two adjacent contact centers shall be ± 0.02 (.10 mm). Tolerance between any two contact centers, other than adjacent contacts, shall be ± 0.076 (1.5 mm).
- Contact identification may be located on either side of the contact hole but shall appear on the front and rear of each insert.
- For certification purposes, this standard takes precedence over procurement documents referenced herein.
- Referenced documents shall be of the issue in effect on date of invitation for bid.
- Complete connectors covered by issues of MS 24003 dated prior to 20 May 1970 are replaced by MS28748/6-A00G1A.
