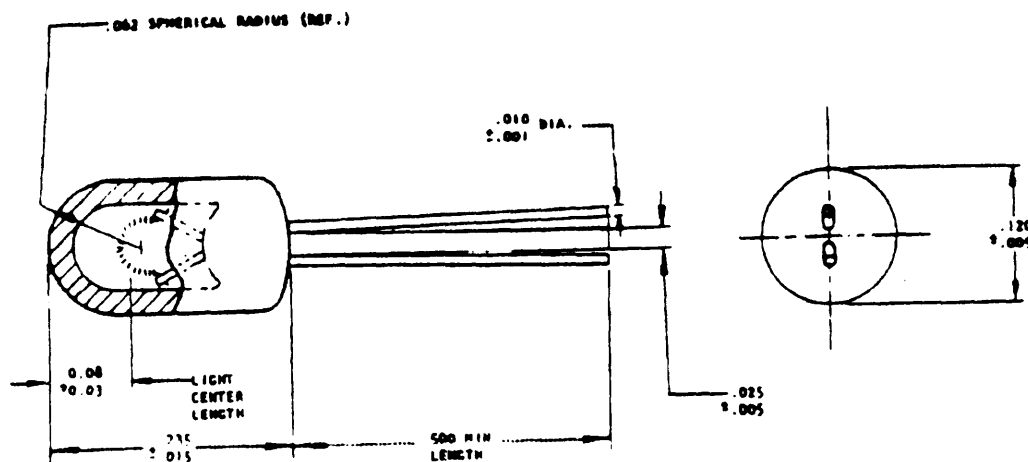

MEAN SPHERICAL CANDLEPOWER (MSCP) MUST BE OBTAINABLE AT RATED VOLTAGE. LAMPS SHALL BE AGED FOR 10 HOURS AT RATED VOLTAGE BEFORE MEASURING MSCP.

MEAN SPHERICAL CANDLEPOWER (MSCP) AT 1,000 HOURS SHALL NOT BE LESS THAN 90% OF INITIAL MSCP WHEN MEASURED AT RATED VOLTAGE EXCEPT IN THE CASE OF 715AS15, WHICH SHOULD NOT BE LESS THAN 85%.

LAMP MANUFACTURER SHALL SUBMIT TEST CERTIFICATION DATA TO PROCURING ACTIVITY TO SUBSTANTIATE LAMP LIFE.

"AS" (AGED AND SELECTED) INDICATES THE LAMPS HAVE BEEN AGED FOR A MINIMUM OF 10 HOURS AT RATED VOLTAGE PRIOR TO SELECTION FOR MSCP.

LEAD WIRES SHALL BE TINNED.

THE VALUES SHOWN FOR AVERAGE LIFE (HRS) ARE TAKEN AT ROOM AMBIENT CONDITIONS AND MAY VARY WITH THE APPLICATION.
