THE PART NUMBER FOR THE ASSEMBLY WITH LAMPS SHALL CONSIST OF THE MS PART NUMBER OF THE ASSEMBLY WITH ADDITIONAL DASH NUMBER, WHICH IS THE TRADE NUMBER OF THE LAMP.

EXAMPLE OF PART NUMBER: MS25277-1-7079 = LIGHT ASSEMBLY WITH TWO MS25338-7079 LAMPS.

THE PART NUMBER FOR THE ASSEMBLY WITH LAMP SHALL BE MARKED ON THE SHIPPING CONTAINERS ONLY.
