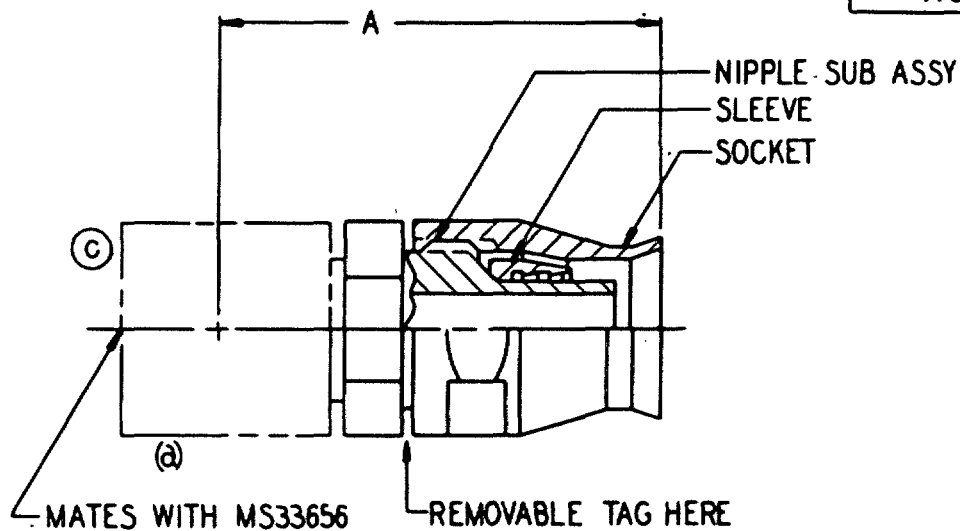

(b) SWIVEL NUT AND CONE SEAT OF NIPPLE SHALL MATE WITH MS33656-3 FITTING. THE REMAINING PORTION OF THE ASSEMBLY SHALL MATE WITH MIL-H-27267-4 HOSE.

(c) MS27053-3C INACTIVE FOR DESIGN AFTER 2 MAY 1966. USE ONLY FOR REPLACEMENT OF IDENTICAL ITEMS IN EXISTING MILITARY EQUIPMENT. USE MS27053-3~~4~~C FOR DESIGN.

(C) "A" IS THE DIMENSION BETWEEN THE HOSE END OF FITTING AND THE FREE END OF THE INSERT AT ITS CENTERLINE WHEN THE SOCKET IS ASSEMBLED ON THE NIPPLE.
