- TEST EQUIPMENT DESIGNED FOR USE WITH 400 HZ, THREE PHASE POWER ONLY SHALL BE PROVIDED WITH MS27603-3 CABLE.
- TEST EQUIPMENT DESIGNED FOR USE WITH 28 V, D-C POWER SHALL BE PROVIDED WITH MS27603-4 CABLE.

SUBSTITUTE ITEMS 2, 4, AND 11, IN LIEU OF 1.
