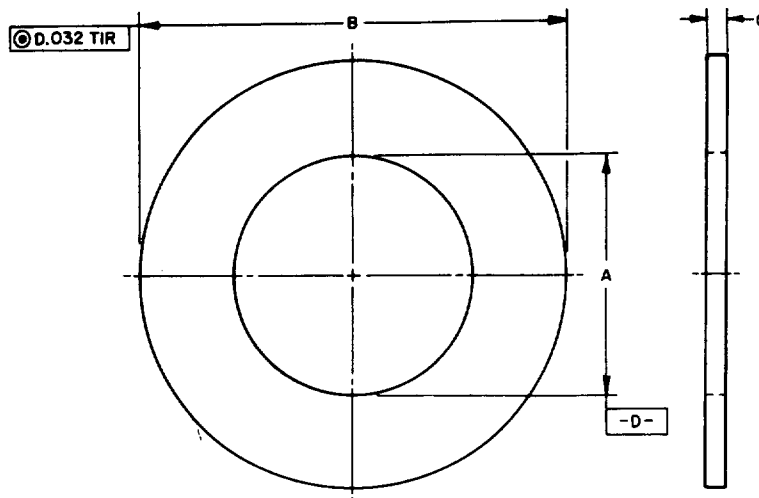

(Z REQUIREMENTS; Z₁ ALLOWABLE DUROMETER HARDNESS SHORE A65-80 AND ULTIMATE ELONGATION 225% MINIMUM, Z₂ PART MUST RESIST -2% TO +20% VOLUME CHANGE WHEN IMMERSSED IN FUEL B FOR 22 HOURS AT 70°F TO 80°F, Z₃ PART OUTSIDE DIAMETER MUST NOT INCREASE MORE THAN 2.5% DURING OR AFTER TESTING IN SPECIFIED MEDIA)

4. GASKETS INSTALLED ON EQUIPMENT IN WHICH THE GASKET IS OVER EIGHT (8) QUARTERS OLD, SHALL NOT BE DELIVERED TO ANY GOVERNMENT SERVICE.
5. DIMENSIONS ARE IN INCHES. UNLESS OTHERWISE SPECIFIED, TOLERANCE IS $\pm 1/64$.
6. REFERENCED DOCUMENTS SHALL BE OF THE ISSUE IN EFFECT ON DATE OF INVITATIONS FOR BID.
7. FOR DESIGN FEATURE PURPOSES, THIS STANDARD TAKES PRECEDENCE OVER PROCUREMENT DOCUMENTS REFERENCED HEREIN.
