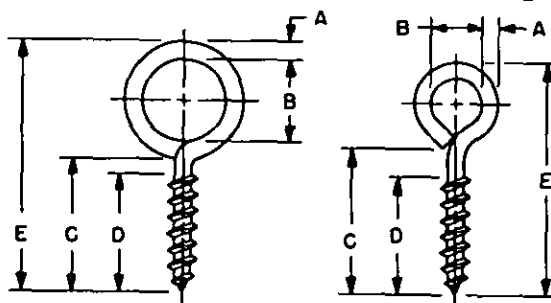

- PROTECTIVE COATING:** Steel - Cadmium plated in accordance with QQ-P-416, Type II, Class 3. Brass - Black chemical finish in accordance with MIL-F-495.
- THREADS:** The threads shall have a wood-screw form, in accordance with the procurement specification.
- DIMENSIONS:** All dimensions are in inches.
- PART NUMBER:** The MS part number consists of the MS number, plus the dash number.
Example: MS35646-501.
- Referenced documents shall be of the issue in effect on date of invitations for bid.
- For design feature purposes, this standard takes precedence over procurement documents referenced herein.
- Wire diameters conform to American Steel Wire Gage.
