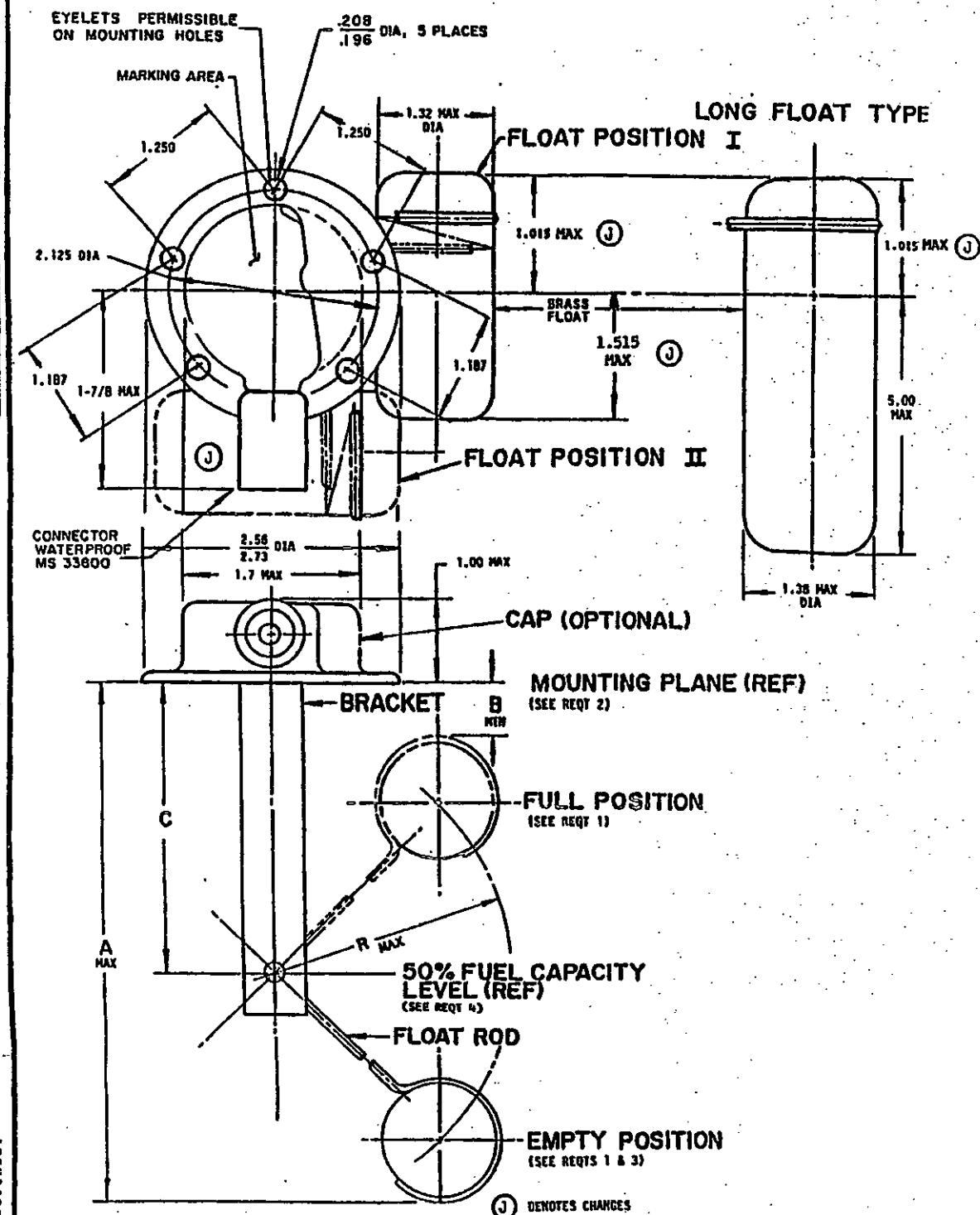

REQUIREMENTS:

1. WHEN TESTED IN ACCORDANCE WITH THE PROCUREMENT SPECIFICATION, RESISTANCE CALIBRATION MEASUREMENTS SHALL BE 0.00 TO 0.50 OHMS AT EMPTY POSITION, AND 29.50 TO 31.50 OHMS AT FULL POSITION.
2. ANY PORTION OF THE ASSEMBLY AS SHOWN BELOW THE INDICATED MOUNTING PLANE (REF) SHALL PASS THROUGH AN OPENING OF 1.562 INCHES IN DIAMETER.
3. FOR NEW DESIGN APPLICATIONS, A FUEL RESERVE OF 10 PERCENT OF THE APPLICABLE FUEL TANK CAPACITY SHALL REMAIN WHEN THE FLOAT FIRST REACHES THE EMPTY POSITION AS SHOWN WITH FUEL TANK LEVEL DECLINING.
4. FOR NEW DESIGN APPLICATIONS, THE FLOAT LEVER FULCRUM, LOCATION OF WHICH IS DETERMINED BY DIMENSION "C", SHALL BE ESTABLISHED IN LINE WITH THE 50 PERCENT FUEL CAPACITY LEVEL (REF) OF THE APPLICABLE FUEL TANK.
5. THE MS PART NUMBER AND MANUFACTURER'S IDENTIFICATION SHALL BE MARKED ON BODY OF TRANSMITTER IN ACCORDANCE WITH MIL-STD-130.
6. TRANSMITTER SHALL HAVE A STEADY AND CONTINUOUS OUTPUT FOR ALL FLOAT POSITIONS AND SHALL TRACK LINEARLY WITH THE FLOAT POSITION.
7. ALL STEEL PARTS, EXCEPT STAINLESS STEEL, SHALL BE ZINC OR CHROMIUM PLATED IN ACCORDANCE WITH PROCUREMENT SPECIFICATION.
8. MATERIAL, FLOAT: BRASS, INCL-LEADED SHEET OR STRIP COPPER ALLOY NUMBER 260 OR 268; ANNEALED TEMPER, SPECIFICATION QQ-B-613 OR ASTM B36.
9. THE USE OF RECYCLED MATERIALS WHICH MEET THE REQUIREMENTS OF THE APPLICABLE MATERIAL SPECIFICATIONS WITHOUT JEOPARDIZING THE INTENDED USE OF THE ITEM SHALL BE ENCOURAGED.

2. FOR ASSOCIATED INDICATOR, LIQUID QUANTITY - 24 VOLT DC ENGINE FUEL SEE MS24544.
3. UNLESS OTHERWISE SPECIFIED, DIMENSIONS ARE IN INCHES, TOLERANCES ARE $\pm .015$ ON DECIMALS, $\pm 1/32$ ON FRACTIONS.
4. THIS STANDARD IS NOT INTENDED TO LIMIT CONSTRUCTION TO FEATURES OTHER THAN AS SHOWN HEREON, BY DIMENSIONS, NOTATIONS, AND REFERENCED DOCUMENTS.
5. FOR DESIGN FEATURE PURPOSES, THIS STANDARD TAKES PRECEDENCE OVER PROCUREMENT DOCUMENTS REFERENCED HEREIN.
