

REQUIREMENTS:

- CONFIGURATION OF ATTACHING DEVICE SHALL BE ACCORDING TO MANUFACTURER'S STANDARD AND SHALL FUNCTION PROPERLY WITH WINDSHIELD WIPER ARM MS500090. NECESSARY ADAPTERS AND MOUNTING INSTRUCTIONS SHALL BE FURNISHED WITH EACH BLADE.
- MATERIAL:
  - A. CHANNEL AND CLIP: STEEL, CORROSION RESISTANT, COMPOSITION 300 OR 400 SERIES PER QQ-S-766; STEEL, CARBON, SHEET OR STRIP, CMC4, TEMPER 3-5, PER QQ-S-698.
  - B. ELEMENT: NATURAL OR SYNTHETIC RUBBER IN ACCORDANCE WITH RR-A-1147.
- FINISH, METAL PARTS:
  - TREAT: PHOSPHATE COATING TYPE I OF TT-C-490.
  - PRIMER: CONFORMING TO TT-P-636.
  - PAINT: ENAMEL, OLIVE DRAB TT-P-465.
  - OPTIONAL FINISH FOR CORROSION RESISTANT STEEL: BLACK DICHROMATE TREATMENT.
- MARKING SHALL CONSIST OF THE MS PART NUMBER AND MANUFACTURERS IDENTIFICATION IN ACCORDANCE WITH MIL-STD-130.
