1. TYPE 1, CLASS 2 (AIR ACTUATED), CATEGORY 1 (12 VOLT DC), OR CATEGORY 2 (24 VOLT DC), OF PROCUREMENT SPECIFICATION.
2. HORN SHOULD BE MOUNTED WITH PROJECTORS POINTING DOWNWARD 15° TO PREVENT ICING.
3. FINISH: HORN SHALL BE PAINTED IN ACCORDANCE WITH PROCUREMENT SPECIFICATION. MOUNTING ATTACHMENTS SHALL NOT BE PAINTED.
4. THREADS SHALL BE IN ACCORDANCE WITH SCREW THREAD STANDARDS FOR FEDERAL SERVICES, HANDBOOK H28.
5. DIMENSIONS ARE IN INCHES. UNLESS OTHERWISE SPECIFIED, TOLERANCES ARE $\pm 1/32$.
6. MARKING SHALL CONSIST OF THE MS PART NUMBER AND THE MANUFACTURER'S IDENTIFICATION IN ACCORDANCE WITH MIL-STD-130.

1. FOR DESIGN FEATURE PURPOSES, THIS STANDARD TAKES PRECEDENCE OVER PROCUREMENT DOCUMENTS REFERENCED HEREIN.
2. THIS STANDARD IS NOT INTENDED TO LIMIT CONSTRUCTION TO FEATURES OTHER THAN AS SHOWN HEREON BY DIMENSIONS, NOTATIONS, OR REFERENCED DOCUMENTS.
