


- MATERIAL. TOOL STEEL TYPE W2 (UNS T72302), AS SPECIFIED IN PROCUREMENT DOCUMENT.
- CONDITION.

9-1/2	.95 - 1.05

GRADE A IS REFERRED TO AS EXTRA OR SPECIAL; THE CHEMICAL COMPOSITION IS HELD TO CLOSEST LIMITS FOR CONTROLLED HARDENABILITY - REGULAR HARDENING.

GRADE C IS REFERRED TO AS REGULAR OR STANDARD; IT IS INTENDED FOR APPLICATIONS THAT DO NOT REQUIRE CONTROLLED HARDENABILITY AND WHERE SOME LATITUDE IN UNIFORMITY IS PERMISSIBLE.

- LENGTH. STANDARD LENGTH OF ROUND WIRE IS 10 FEET MINIMUM, 12 FEET MAXIMUM.
- FORMING PROCESS. HOT FORMED.
- FINISH. AS SPECIFIED IN PROCUREMENT DOCUMENT.
- HEAT TREATMENT. ANNEALED.
- PART NUMBER. THE PART NUMBER CONSISTS OF THE BASIC MS NUMBER, PLUS A DASH NUMBER FROM TABLE I.



- MARKING. TOOL STEEL SHALL BE MARKED IN ACCORDANCE WITH FED-STD-183 WITH THE EXCEPTION THAT A PART NUMBER FROM THIS MILITARY STANDARD SHALL BE INCLUDED AS PART OF THE IDENTIFICATION MARKING.
