

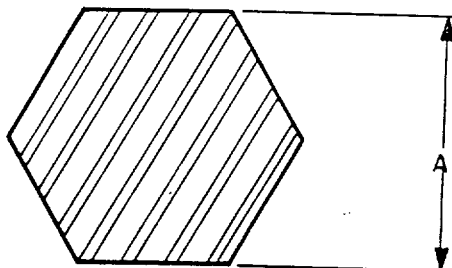

## REQUIREMENTS:

1. MATERIAL. TOOL STEEL TYPE S5 (UNS T41905), AS SPECIFIED IN PROCUREMENT DOCUMENT.
2. LENGTH. STANDARD LENGTH OF HEXAGON BAR IS 10 FEET MINIMUM, 12 FEET MAXIMUM.
3. FORMING PROCESS. HOT FORMED.
4. FINISH. AS SPECIFIED IN PROCUREMENT DOCUMENT.
5. HEAT TREATMENT. ANNEALED.
6. PART NUMBER. THE PART NUMBER CONSISTS OF THE BASIC MS NUMBER, PLUS A DASH NUMBER FROM TABLE I.

7. MARKING. TOOL STEEL SHALL BE MARKED IN ACCORDANCE WITH FED-STD-183 WITH THE EXCEPTION THAT A PART NUMBER FROM THIS MILITARY STANDARD SHALL BE INCLUDED AS PART OF THE IDENTIFICATION MARKING.
