1. MS PART NUMBERS - The MS part numbers of the batteries shall be MS90365-1 and -2.
 2. DESIGN STANDARD - Each battery shall conform to MS18093 for size number 3.
 3. NOMINAL CAPACITY - The nominal capacity of each battery shall be 16 ampere-hours.
 4. MAXIMUM WEIGHT - The weight of each battery filled with electrolyte shall not exceed 55 pounds in any state of charge.
 5. SPECIFICATION - The batteries shall conform to requirements of MIL-B-8565 for maintainable, ventilated, receptacle-connected, cradle-mounted, heavy duty high discharge rate batteries modified as follows:
- 4.7.25 Special Tests - For MS90365-1 batteries, add:

4.7.25.1 Step Discharges - The battery shall be subjected to three 15-second discharges and then a 30-second discharge, with a 1-minute rest period between each two consecutive discharges, all at 0 F. The current shall be maintained at the value listed below for each period listed below during each discharge. The potential during each period of each discharge shall not be less than the value listed below.

4.7.25.1 Step Discharges - The battery shall be subjected to three 23-second discharges, with a 2-minute rest period between each two consecutive discharges, all at 0 F. The current shall be maintained at the value listed below for each period listed below during each discharge. The potential during each period of each discharge shall not be less than the value listed below:
