(E)	Α.	<ul> <li>For the first LD or structural LE Recertification, develop a LD- or LE-specific Recertification Procedure to include at least the following. For simple, Nonstructural LE (shackles, rings, etc.), a generic Recertification Procedure must Include at least items 2, 3, and 4 below. A table of values may be provided to comply with item 3.</li> <li>Identification of LE critical welds.</li> <li>Type and extent of NDT, including visual inspections, to be performed prior to Rated Load Test. Acceptance criteria must be provided.</li> <li>Step-by-step procedure for Rated Load Test, including the applied test load. Note: This procedure may be generic for multiple types of LE.</li> <li>Type and extent of NDT, including acceptance criteria, to be performed subsequent to Rated Load Test.</li> </ul>
(E)	B.	For subsequent LD or structural LE Recertifications, review existing LD- or LE-specific Recertification Procedure for continued applicability. (If the Configuration has changed, or if the LD or LE has been structurally modified, Follow 540-WI-8719.1.1, Certification of New or Modified Lifting Devices (LD) and Lifting Equipment (LE)).
(E)	C.	Obtain RECERT Manager's approval of Recertification Procedure.
(I)	D.	<ul> <li>Perform pre-Rated Load Test NDT.</li> <li>1. If acceptable, proceed to STEP E.</li> <li>2. If unacceptable, the item is rejected. Proceed as directed by the RECERT Manager.</li> </ul>
(I)	E.	<ul> <li>Perform Rated Load Test.</li> <li>1. If acceptable, proceed to STEP F.</li> <li>2. If unacceptable, the item is rejected. Proceed as directed by the RECERT Manager.</li> </ul>
(I)	F.	<ul> <li>Perform post-Rated Load Test NDT.</li> <li>1. If acceptable, proceed to STEP G.</li> <li>2. If unacceptable, the item is rejected. Proceed as directed by the RECERT Manager.</li> </ul>
